Notice Requirements - Sample Calculation

Occasionally there can be disputes regarding when notice of a meeting was properly given. Set out below is a sample calculation of the notice requirements for a general meeting.

Please note that section 160 of the Evidence Act 2011 provides a rebuttable presumption that an article sent by prepaid post was received on the 4th *working* day after posting. In addition to this 4 working day period, you must add the 14 or 21 *calendar* day notice period under the Unit Titles (Management) Act 2011 (**UTMA**) so that the general meeting occurs, at the earliest, on the 15th or 22nd calendar day after deemed receipt.

A record should be kept of the date the notices were sent, who sent them and confirming that office processes were adhered to.

Thursday	2 April 2015	1st working day after postage	Notices may be served by sending it by prepaid post as a letter to the relevant address on the corporate register – s 124 UTMA;
			Service by post is taken to be effected on the 4th working day after posting – s.160 Evidence Act
Friday	3 April 2015	Good Friday	This is a public holiday and therefore does not count as a working day
Saturday	4 April 2015	Easter Saturday	This is a public holiday and therefore does not count as a working day
Sunday	5 April 2015	Easter Sunday	This is a public holiday and therefore does not count as a working day
Monday	6 April 2015	Easter Monday	This is a public holiday and therefore does not count as a working day
Tuesday	7 April 2015	2nd working day after postage	
Wednesday	8 April 2015	3rd working day after postage	
Thursday	9 April 2015	4th working day after postage	Deemed date of receipt under Evidence Act 2011
Friday	10 April 2015	1st day of 14 day notice	
Saturday	11 April 2015	2nd day of 14 day notice	Weekends counted this time as s.3.6 of Schedule 3, refers to 14 days not 14 working days notice
Sunday	12 April 2015	3rd day of 14 day notice
